Minutes of the CRETINGHAM, MONEWDEN AND HOO ANNUAL PARISH COUNCIL MEETING

held on Tuesday 17th May 2022 at 7.30pm at Monewden Village Hall

- **45. To elect Chairman** Cllr Alister Gourlay was proposed by Cllr Chenery and Seconded by Cllr Egan and was elected unanimously. Cllr Gourlay signed the Declaration of Acceptance of Office
- **45.1 To elect Vice Chair** Cllr Alan Peat was proposed by Cllr Gourlay and Seconded by Cllr Chenery and was elected unanimously.
- 45.2. Apologies accepted from Cllr Michael Oliver and District Councillor Lydia Freeman
- 45.3. Declarations of Interest and to accept any dispensations None received
- **45.4** To consider confirming the Minutes of the Parish Council Meetings on **15** thMarch **2022** and **16** thApril **2022** these were accepted and signed by Clly Gourlay. Cllr Gourlay thanked the Clerk and Councillors for their work.
- **45.5** To consider councillor applications from Tessa Solomon, Jim Gould and Andrew Branton for 2 vacant parish council seats councillors had been sent the applications in advance of the meeting. Voting was by secret ballot with the first ballot being for the Hoo Vacancy. Andrew Branton received the most votes and was co-opted as Councillor for Hoo. A second round of secret voting this time for the Cretingham vacancy took place with Tessa Solomon receiving the most votes. Tessa was then co-opted as Councillor for Cretingham. Cllr Gourlay will let all applicants know the result of the election.

45.6 Matters for debate

- **45.6.1** Confirmation of PC rep on The Cretingham Townlands Trust it was agreed that Helen Marjoram would be confirmed as the Parish Council representative on the Cretingham Townlands Trust .
- **45.6.2** To discuss maintenance of notice boards it was agreed that Cllrs Chenery and Peat would have a look at our notice boards and report back at our next meeting
- **45.6.3** To discuss Charitylands tree planting there is a new scheme available to landowners under the England Woodland Creation Offer (EWCO) where a grant is available for £8,500 a hectare for planting trees plus £200 a year for 10 years for maintenance as well as additional grants if there is a public benefit. Cllrs Martin and Chenery will look into this further and advise at a future Parish Council meeting
- **45.6.4** To discuss Monewden Airfield it appears that the airfield is exceeding its permitted number of movements under the certificate of lawfulness and it was agreed that the clerk would write to District Councillor Freeman asking her to a meeting to discuss this and ask her to involve the District Council planners to discuss the situation. Also a letter should be sent to our MP advising him of the present position regarding the airfield
- 45.6.5 Councillors reports None received
- **45.6.6** To receive any reports from Councillors from SCC and East Suffolk County Councillor Elaine Bryce attended the meeting and let councillors know that her written report would be following

shortly. She also discussed highways issues as these have taken up a lot of her time in her first year. She mentioned that she has two locality budgets available – a general budget and a highways budget. It may be that we can apply for funds for our signs from the highways budget.

45.7 To approve audit and recommendations – SALC audit sent to councillors Recommendations –

- 1) Council revisits AGAR and adjusts Box 2 to show £2,603 and Box 3 to show £887 already done
- 2) Council should note guidance as issued under the Practitioners Guide which states that an authority needs to have regards to the need to put in place a General Reserves Policy and have reviewed the level and purpose of Earmarked Reserves this was discussed. Reserves are currently high as the clerk is unpaid. The council was encouraged to increase reserves in the case of a possible election and has reserves to assist in payment of a clerk when necessary as the precept would not cover the salary of a clerk at present.
- 3) Council publishes on its website a website accessibility statement. Regulation 8 of the Public Sector Bodies (Website and Mobile Applications) (No 2) Accessibility Regulations 2018 Clerk will bring this to council at a later meeting.

The council approved the audit and recommendation unanimously.

45.8 To pass resolution to opt out of external audit and approve Certificate of Exemption and **Annual Governance Statement** – this was unanimously approved by the council
